## **President's Foreword**

I am pleased to present this fourth issue of ISOCARP REVIEW, a yearly publication that explores specific facets of the annual ISOCARP Congress theme.

This thematic publication is the result of an initiative taken by my predecessor Alfonso Vegara in 2005. From the outset it proved to be a remarkable way of providing ISOCARP members with a quality publication devoted to the highlights of their congress. The positive international reactions to ISOCARP REVIEW 01 to 03 have encouraged us to continue what has now become a well-established tradition.

REVIEW 04 contains a selection of studies related to this year's congress theme: "Cities without sprawl: a way towards sustainable urbanisation".
